
This is a calculated, direct response towards all allegations and claims against me (Rivernook).

This doc will serve the purpose of not only explaining the context to things I've said, proving the following:

- I am not a pedophile.
- I am not a groomer.
- I have consistently taken measures to prevent minors from accessing inappropriate content on my platforms.
- The allegations against me are based on misinformation and intentional manipulation.
- I have acted ethically and responsibly in all relevant contexts.
- The evidence used against me has been misrepresented or fabricated.
- I have upheld moral and legal standards in my actions and decisions.

But also proving that my accusers have acted dishonestly and with malicious intent

If you're currently unaware of the context, on the 27th of October 2024 some close friends of mine began countless rumours about me, which largely went taken at face value, and unquestioned. These rumours ranged from "allegations" that I was a pedophile, to even suggestions that i was somehow a CP distributor

Before i begin it's important to let you know who is responsible for these rumours in the first place, Which is

1. **Tonida**
 2. **Nepeta**
 3. **Tarowo**

Before I begin, I want to preface something:

I have always been open about my sexuality.

The conduct shown in the PDF was between what I thought was with close friends that were fine with my behavior, my work, and my venting.

One of these main people and the main perpetrator of the PDF was **Tonida**, who had lied and manipulated me, which he admitted here:

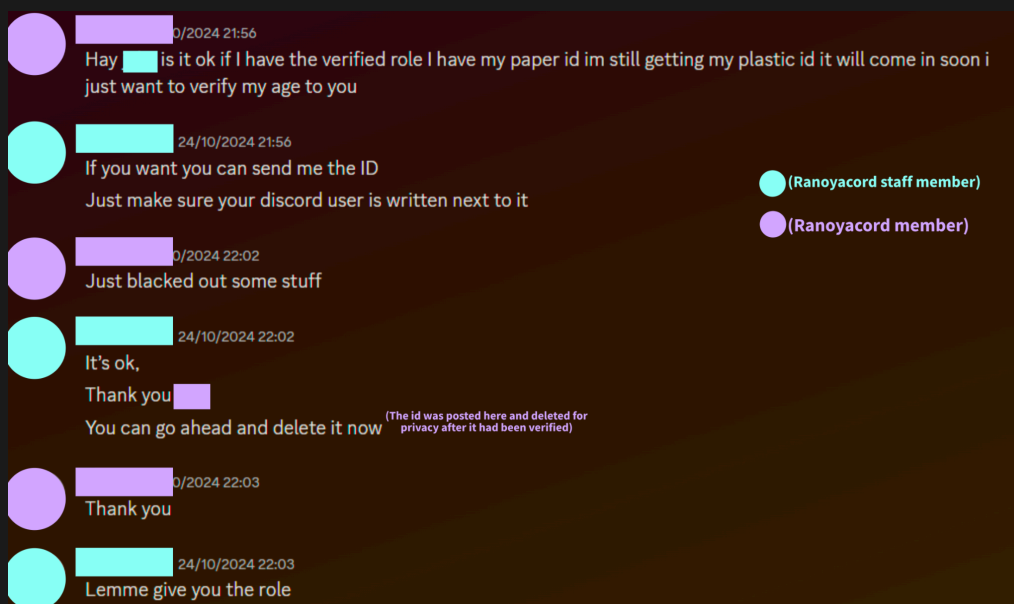
- Never have I publicly acted like this in the leaked messages shown in the PDF,
- Never have used either persona for such conduct
- I have never coerced anyone (especially under 18) to engage and indulge in Ranoyacord, or RR34 for that matter.

Claim: my server had ZERO age verification

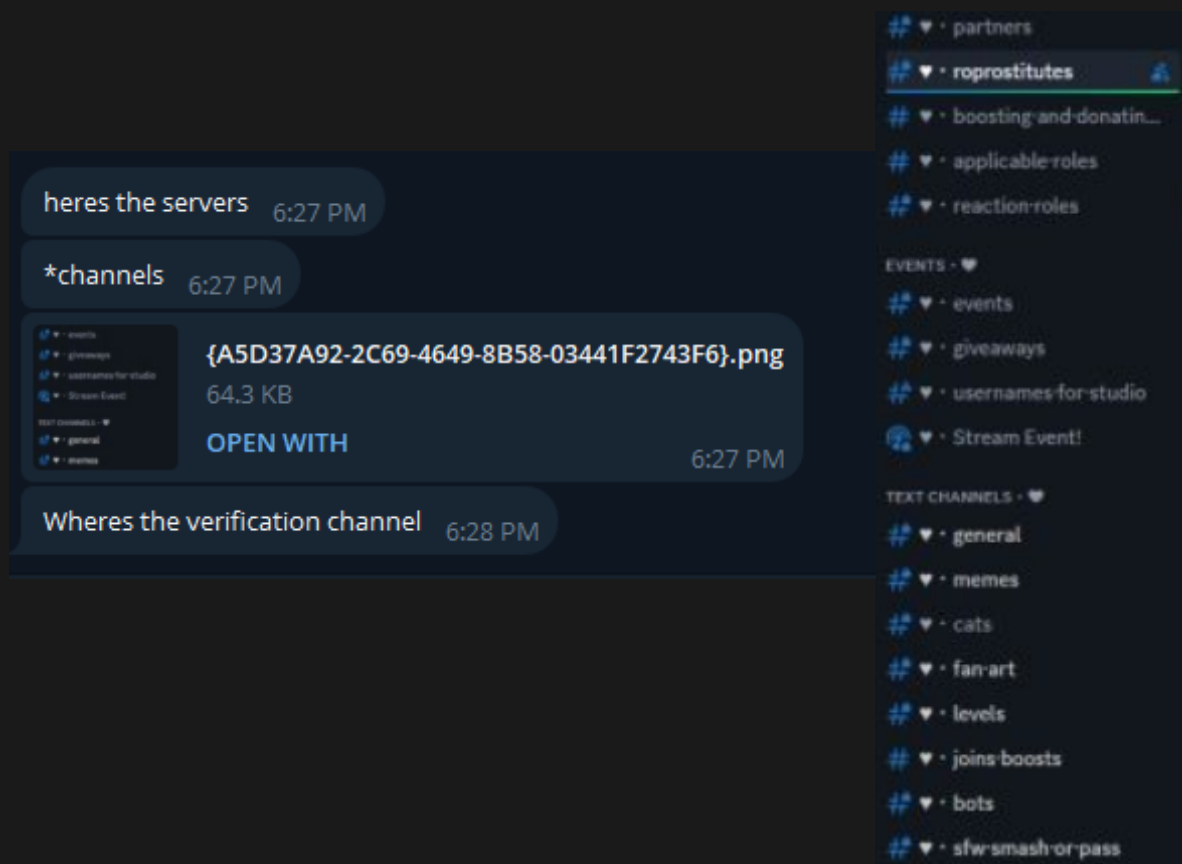
Response: Ranoyacord served the purpose of a fan server for a channel I owned on an 18+ site, it was one of many 18+ servers on Discord, however mine was specifically deemed “Pedophillic” over there apparently not being enough age verification or because it was on Roblox, respectively, both are not true and reductionist.

Many screenshots of the age verification portion of the server was deliberately cropped out by Tonida (an admin on Ranoyacord) to exaggerate this false rumour.

On the 27th of October, Tonida used his admin in Ranoyacord to nuke the server, and in the process erase most evidence of age verification.

Like I mentioned earlier, here's an example where they deliberately leave out a critical fact:

unlocked-for-all

Unlocked-for-all = open to users (no lock icon)

Locked-for-all = closed to users (lock icon)

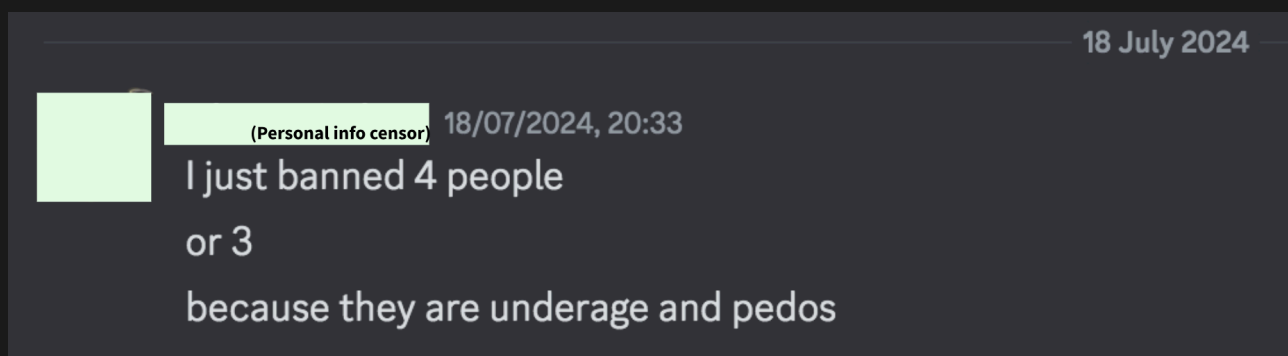
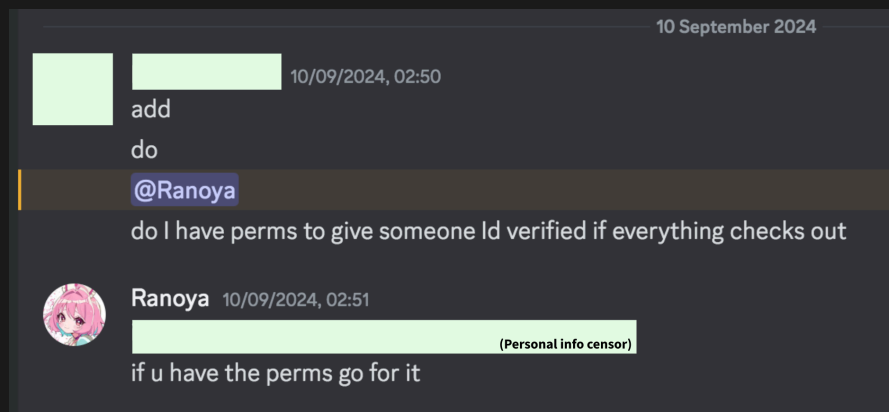
This means that in order to have access to these channels, you need to verify and agree you are 18 or older on our server.

This is just one example of verification on the server since they claim there is NO verification whatsoever.

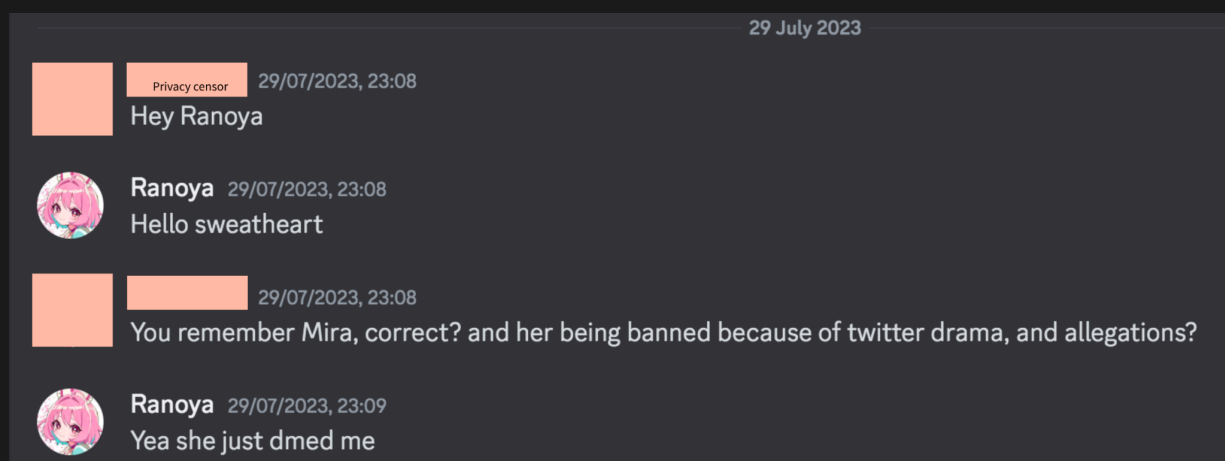
For ID verification, that was a role that was given to people that were able to verify by ID.

Age checks occurred randomly, and mods inspected profiles to catch minors easily, additionally we had a channel where people would get age checked to access the NSFW side of the server.

Here's some additional evidence age verification and the banning of minors WAS present in Ranoyacord its entire existence, the screenshots show dms between myself and some of my moderators who managed the system.



Here's an additional screenshot that mentions active moderation in ranoyacord that goes back all the way to 2023:



Evidence like this is so crucial because it disproves the false rumours that so many people have been manipulated to believe that ranoyacord had no moderation to keep minors or pedos out at all.



Discord member lists are in alphabetical order.

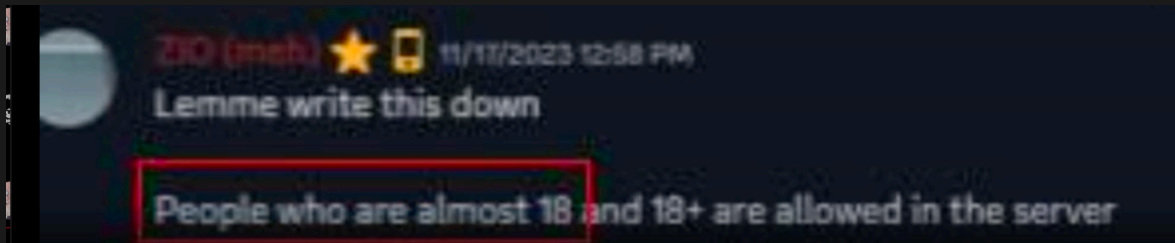
This means that out of 5,000+ members, this dumb fuck had to scroll atleast through $\frac{2}{3}$ of the server in order to find someone with a one letter nick as the last alphabetical letter that got missed by the staff team.

This was their best evidence of “active minors” in ranoyacord and yet it’s so cherry-picked and pretentious it’s laughable.

“Almost 18” and Zio

Claim: Ranoyacord willfully harboured minors



Response: This screenshot above from Ranoyacord has been spread around for “evidence” that ranoyacord willfully harboured minors, however it leaves out the context that this admin (ZIO) was demoted for this enabling and unstable behaviour:

The message he left in rules WASN'T agreed upon among ranoyacord staff, and it was a rule he wrote there under his own pure volition. He was not demoted for this, however:

When confronted, he became an emotional wreck, and while in retrospect I should've put my foot down, I am not someone who can confront people properly (more info later), and I was still figuring out maintaining a relatively young server/brand, so I let it pass without realizing the consequences of this statement ZIO put in place.

I would also like to clarify that Ranoyacord was NOT a "Condo server", If you are unaware what a condo server is, it's a discord server that uploads pornographic games to Roblox for people to play.

My server was focused on making animated 18+ video content purely for an 18+ site, which is a big difference morally, however because of the genre and how manipulatively these "Allegations" were framed this misconception remains.

TONIDA & NEPETA

These two are especially important for context given the fact they were the first to begin the allegations in the first place.

Additionally its important context to note AGAIN:

Tonida WAS admin for a long time at Ranoyacord, meaning he knowingly was being untruthful about many of the details surrounding it.

However Tonida himself despite being the person to start these allegations has admitted that he doesn't even believe them himself:

Hey guys. I've had some time to reflect on everything that happened with Rivernook. I would like to start off by saying admitting the the situation was handled poorly on our part, and I know I was wrong to largely take part in something that ultimately tarnished Nook's reputation. I did not fully think about the consequences of what I was doing, and I now realize how damaging it was to him personally.

Admitting the allegations werent true

I want to make it clear that Nook is not the person we painted him out to be, a "pedophile". He did not deserve to have his reputation taken away or to be labeled as something that's not only unfair and false, but also harmful, given the stigma surrounding the word. I take full responsibility for my role in that, and I deeply regret the harm that it caused. Recently, Nook and I have talked, and I now see that he never intended to harm anyone, but rather to make others happy through his content.

On behalf of everyone involved, I think it's only fair that we repair Nook's image by clearing up all these harmful allegations against him. Sure, Nook may have done some questionable things, but he never had any ill-intents, nor did he deserve any of this. He is still human at the end of the day, and his irresponsibility and foolishness does not justify the harsh treatment that was given to him that day. I also want to say that I am truly sorry for any pain or frustration our actions have caused to Nook, friends, and the TriHard community/Soysphere.

Thanks for reading, and I hope we all can learn and move on from this eventually.

Furthermore, I have only ever met this individual on the 19th of November, long after Ranoyacord had ceased to exist.

There's very little excuse for lies like this given the fact Tonida was an admin himself in Ranoyacord so he fully understood that this was untrue, yet allowed this lie to continue to be pushed anyways.

Above you can see Tarowo openly admitting he never actually cared about the doc and treated it more like a joke, which makes many of the allegations against me even more questionable in their authenticity.



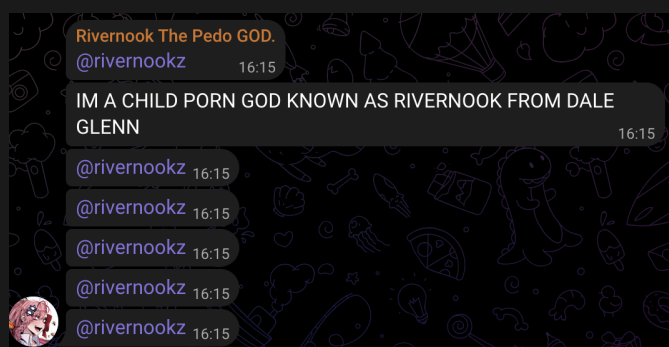

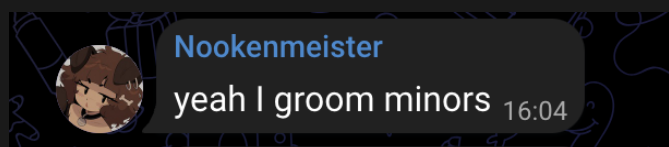

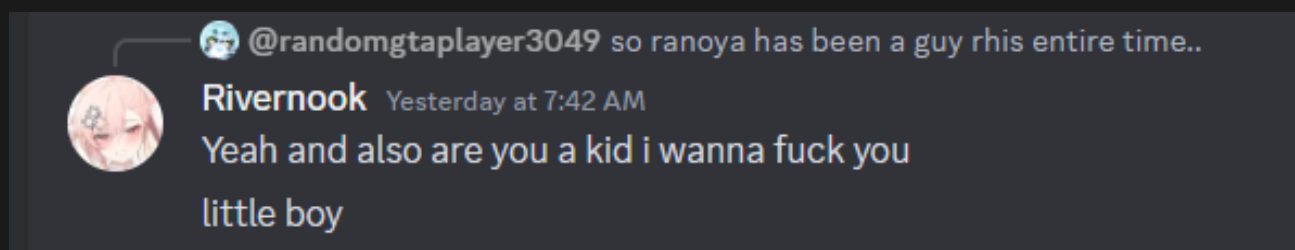
And some more instances of impersonation for good measure, how can anyone take these allegations seriously given the fact that the people who started them don't in the first place?

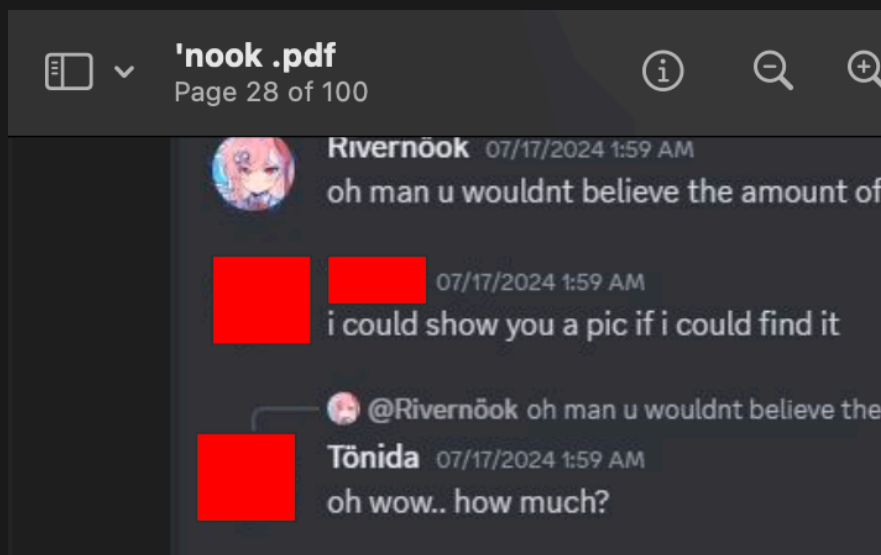
Context, and Cropping

Longest part of this doc that directly responds to all assumed or direct claims against me.

During my relationship with Tonida I very much saw him as a moral role model due to him being older and wiser than myself, and as a result I would confide in him about many moral dilemmas and feelings in which he would entertain and help me work out those feelings, which he has recently taken out of context to make me appear to be a bad person.

Almost every screenshot you see of me was in Tonidas DMs.

However he censored his username to “protect” himself, except for one slide which was uncensored in the ‘Nook pdf:

Claim: I condone minors participating in explicit Roblox games and I failed to ban minors from Ranoyacord.

Position: In this conversation, I was reflecting on how prolonged exposure to X desensitized me to Y as a result from my emotional numbness, and this was not an endorsement of such situations but as a result of my own experiences.

This image has been misrepresented a multitude of times even Ruben Sim himself posted it.

I never actually practiced what the PDF claimed I did.

I have always understood, both morally and logically, the harm and wrongness in these contexts. I have taken steps to lock my server down with age verification, ban minors from my discord server and actively oppose such enabling environments, demonstrating my real opinions on this matter. The problem with misrepresenting my words is that actions DO speak louder than words.

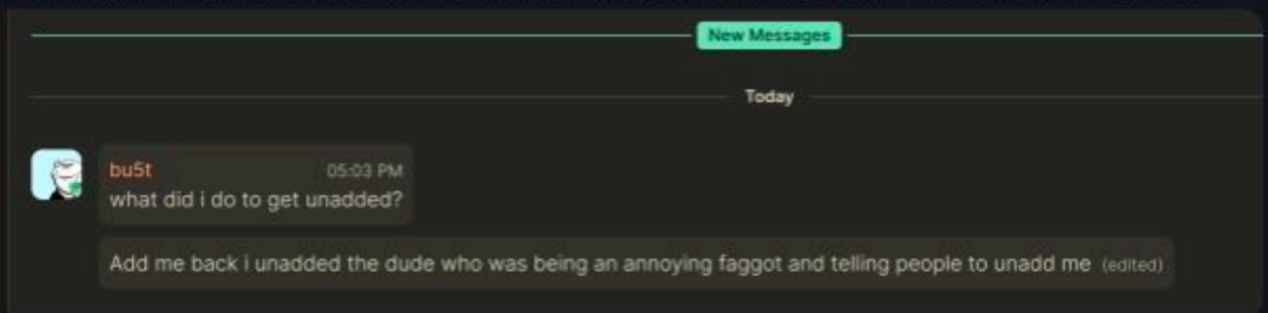

Claim: I talked to Bu5t and refused to unfriend him because I sympathized with him

Position: Bu5t (Connor) was a very prominent member in Sharty, and a prominent raider too.

On September 20th, it was exposed that Bu5t was grooming a discord user named manglegirl188/Mangle, who was 16.

The logs here are from August, the sentiment was rapidly developing that Connor was a CP spammer and Cat Gore spammer, and later as you will see, I found out about Mangle. So why did I feel any sympathy towards this person?

Tonida decided to leave out crucial and much needed context towards my feelings of Connor:

I talked to Mangle myself, and I was upset at what Connor had done.

At the time, Connor had given me much motivation to continue with raiding clips. However, when I found out, I realized that it would be hard cutting off someone who was a big motivator for me that wasn't **Tonida**.

Tonida isolated these dms from each other and did this on purpose to make me a sympathizer to someone like Connor, this is a common theme of painting me as a sympathizer in this PDF.

Why I said I felt bad and why I'm so non confrontational:

GLOV3 is someone I used to talk to and I was very close with. He used to do raids with me and was one of the only people to reach out and talk to me after October 27th.

On January 22, 2025; There was a shooting at Antioch High School. The perpetrator was a Black Soyteen that was groomed by 764, one of the people that contributed to this grooming was GLOV3 (PuppyKnot in this SS):

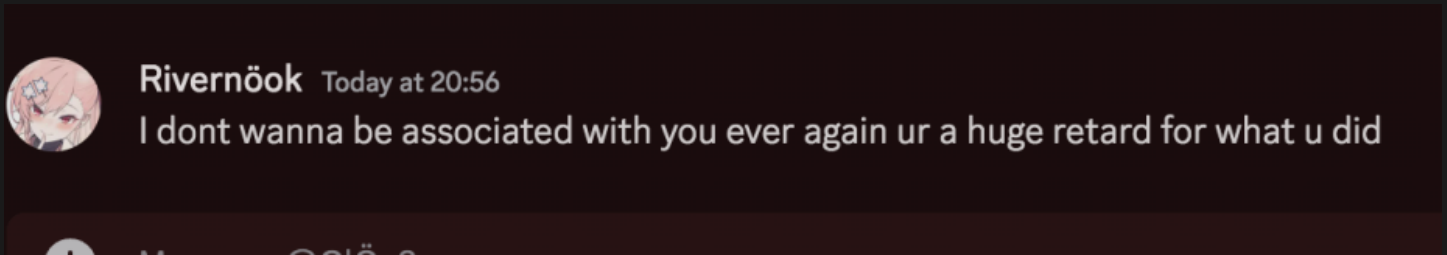

I had a moment of conflict, just like with Connor, a person who motivated me, loved what I did, I had to cut them off, again.

It was like deja vu. It took me a minute to recollect what I wanted to do, but I sent him the following message, wiped our dms, and I stopped talking to him fully:



I felt bad for Connor, because he was trying so hard to try and stay in contact with me, he blocked people for me, and he motivated me heavily, just like GLOV3. I felt bad, but I knew he was a morally corrupt person who needed this wake-up call that no one wanted to interact with him because of his behavior.

Tonida, knowing the actual reason why I did this and the reason why I am not confrontational, left this crucial part out and painted me as a sympathizer.

And yes, I hate what bu5t did, the shit he spammed, and the problems he perpetrated from his corrupt. I'm sorry for what happened to Mangle, and I hope she recovers.

I do admit though that these people in these videos would've actually met up with a kid, they would not only molest them but probably kill them too.

However the actual intent is not me being sympathetic to pedophiles, but being the ethics of violence as a response to criminal behavior. This is a huge mischaracterization and one that separates me from someone who is empathetic towards violence, and one who feels bad for pedophiles.

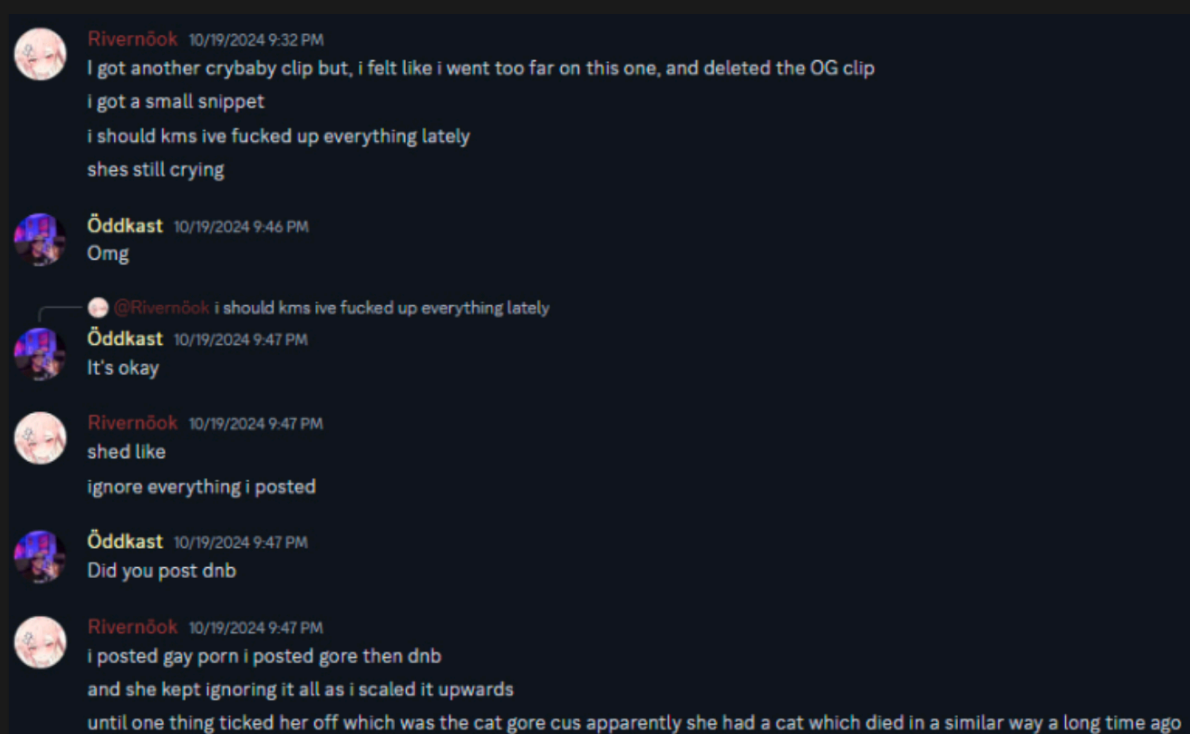

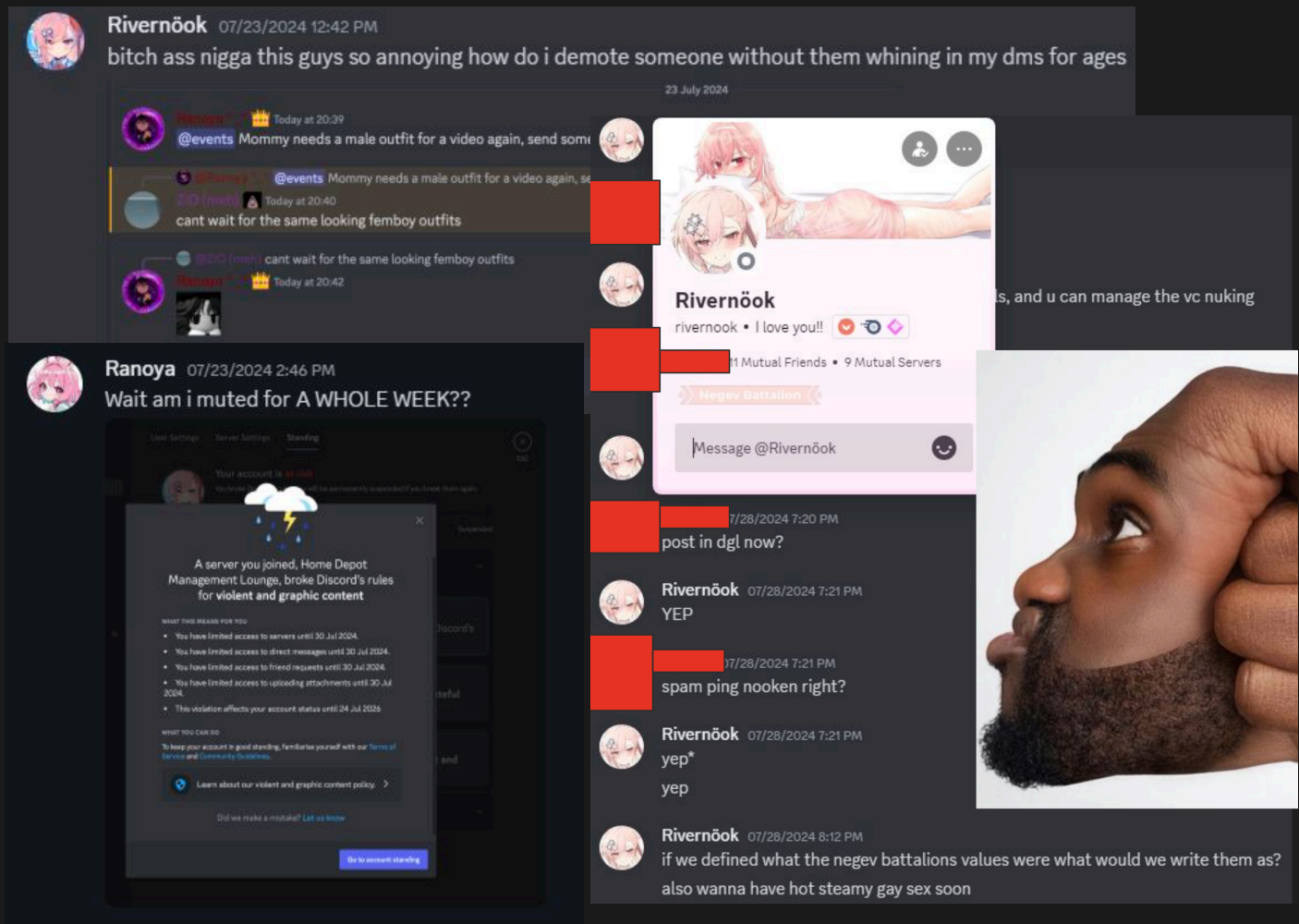
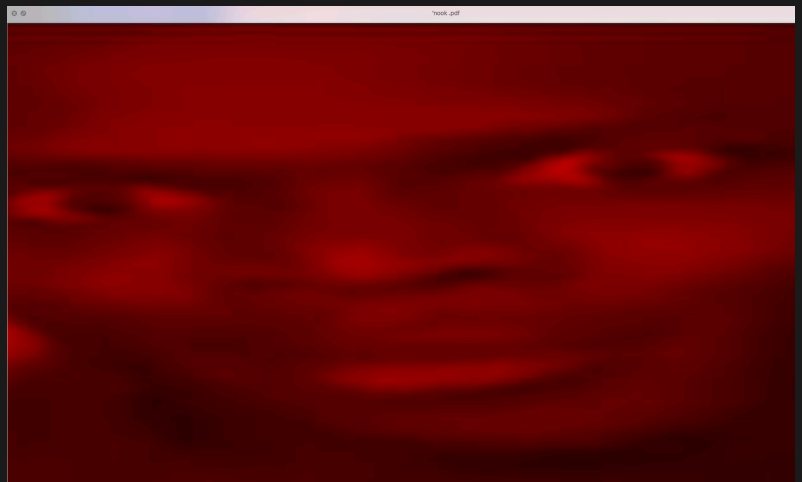
What I was trying to express here was just the satisfaction from seeing very close friends (who were willing to engage with RR34) enjoy a genre I was into.

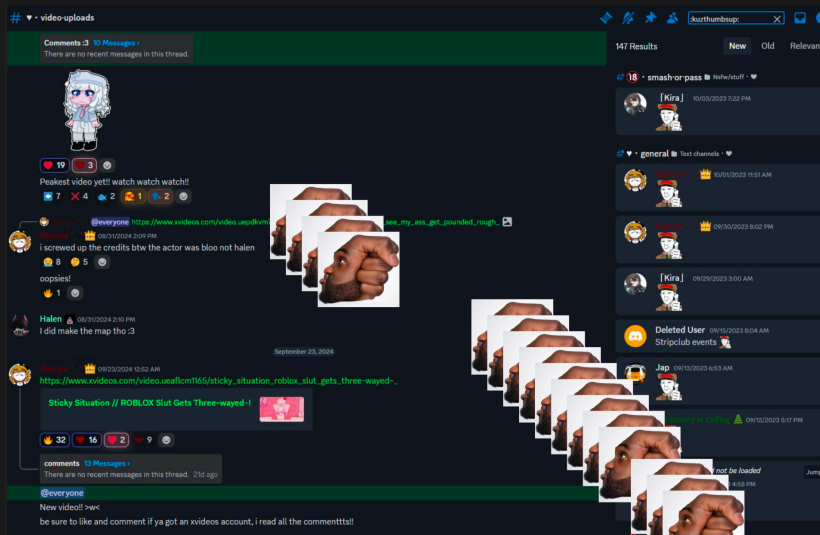
I didn't explain it well, but it certainly did not help **Tonida** left out the most important bit of context here.

For whatever strange reason they felt the need to include countless irrelevant screenshots in the doc, here's a few examples

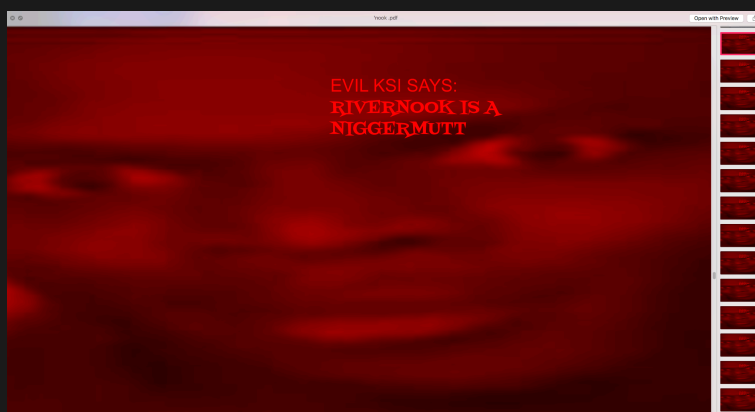




Their main allegation is that I'm a pedophile and a majority of their doc of "evidence" is screenshots of me posting soyjaks...?
